Judge Bozzuto received a B.A. from Manhattanville College in 1985. She was awarded a *juris doctorate* from Western New England College, School of Law in 1988. In 1991 she received a certificate from the National Institute of Trial Advocacy, at Hofstra University in Hempstead, New York.
