On May 30, 2020 the Town of Fairfield Community and Economic Development Department conducted a desk top review of Connecticut Legal Services. The following is a summary of the:

- As of March 31, 2020, eight (8) clients have been served. This is 14.3% of the total goal of 56 individual clients for the program year.
- Clients are screened by State wide service and income is verified.
- Budget is on target and 50% of the funds have been drawn down as of June 30, 2020.
- Leveraging of funds is also on target for this program year.
- Next two quarterly reports will provide information on the outreach and education sessions that have taken place during this program year.
- Records are retained for at least four (4) years and are backed up electronically.

Connecticut Legal Services has been recommended for continued funding and we look forward to working with you and your staff in the new program year. Your official PY46 (10/1/20 - 9/30/21) allocation will be \$4,000. If you have any questions please do not hesitate to contact me at 203 256-3120.

The Office of Victim Services (OVS) has completed its' review of the grant awarded to Connecticut Legal Services for the Domestic Violence and Sexual Assault Legal Representation Project under the U.S. Department of Justice's Victims of Crime Act (VOCA) Victim Assistance Program. The onsite review consisted of a review of financial and program records related to the grant-funded project as well as a review of general agency policies and procedures.

#### Financial Records

Connecticut Legal Services complies with established financial rules governing the management of the grant. No findings were noted during the review of the financial records for the Domestic Violence and Sexual Assault Legal Representation Project.

- > The accounting system reports project funds separately from other agency funds as required by state and federal regulations.
- > Procedures are in place to ensure that expenses allocated to the project are in accordance with the approved budget.

- > Sufficient documentation exists to support the allocation and allowability of expenditures charged to the project.
- > Sufficient documentation exists to support the allocation and allowability of expenditures used as required match for the project.
- > Systems are in place to provide sufficient documentation for project-related time and attendance.
- > Systems are in place to provide sufficient documentation that Connecticut Legal Services adequately monitors subcontracted financial activity.

## Policies and Procedures/Client Files/Program Records

No findings were noted during the review of the agency's policies and procedures, client files, and other program records, however, we do have two items for follow-up as noted below.

- > Civil Rights/Equal Access Compliance The agency is compliant with federal civil rights requirements regarding equal access to services.
- Client Records Based upon a review of project files and client records, all reviewed files appear complete with adequate documentation to indicate that services meet VOCA guidelines.
- Policies and Procedures Policies and procedures are complete and well documented.
- > Recordkeeping and Reporting Client records are maintained in a secure manner to ensure confidentiality.
- > Recordkeeping and Reporting The recordkeeping and reporting systems are maintained in a manner that allows for verification of reported statistics.

### Acknowledgement of Federal Funding Support

During the OVS review of project materials, it was noted that program brochures do not contain an acknowledgement of VOCA funding. The Project Manager indicated that it would be included in the next reprint.

# Assistance with Victim Compensation


