Governing Structure: The Executive Director (ED) is responsible for the day-to-day running of the organization and reports to the Board of Directors (Board). The CLC Board consists of 14 diverse members who meet at least 9 times/year and are committed to the support and governance of the organization. Board members raise money, cultivate donors, and act as ambassadors for CLC. The Board also acts as a fiduciary, selects the ED, evaluates the ED, ensures compliance with legal and tax requirements, and evaluates CLC's work. The Board and Executive Director work together as a team to assess financial and programmatic issues and develop sound strategic plans to address any challenges. Board members also actively participate in at least one of five committees: Governance, Advocacy, Development, Finance, or Programs. Staff size: 10 full-time staff, 1 part-time staff.
