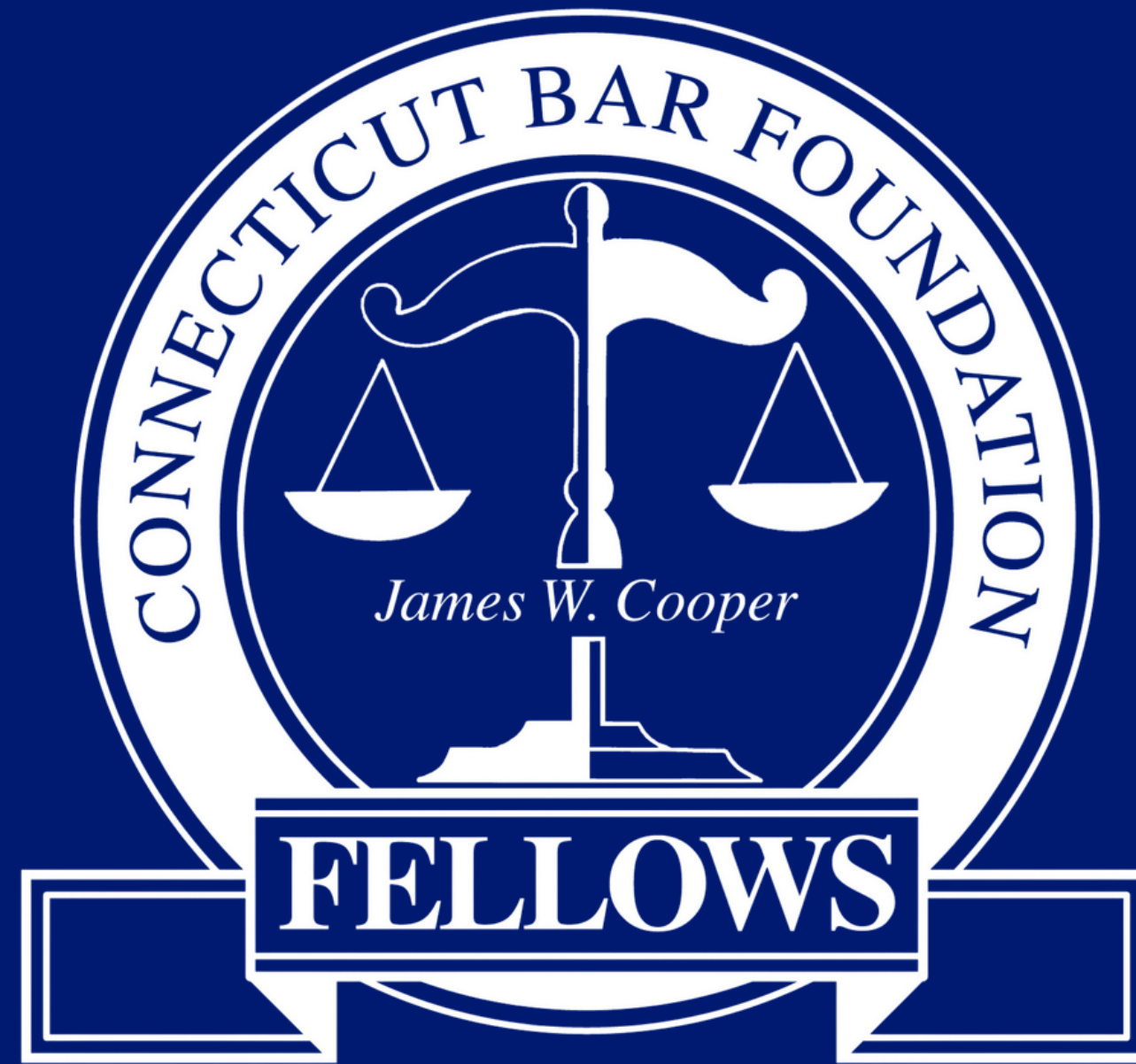

The James W. Cooper Fellows Program is administered by the Connecticut Bar Foundation. The Foundation's primary purpose is to ensure that the state's legal system is available to all, regardless of power or resources. To fulfill this mission, the Foundation administers grants to legal service organizations that represent those who cannot afford private counsel and funds law school scholarships based on financial need.

In addition, the Foundation administers programs with the James W. Cooper Fellows that enhance public understanding of the rule of law in a democratic society and promote improvements to our laws and legal institutions.

Who was James W. Cooper?

The Fellows Program is named in honor of James W. Cooper, who was a prominent New Haven attorney, senior partner of Tyler, Cooper & Alcorn, and tireless advocate and supporter of legal aid. He served as President of the Connecticut Bar Foundation from 1973 to 1975, the Connecticut Bar Association from 1957 to 1958, and the New Haven County Bar Association from 1948 to 1949, and was a Fellow of the American Bar Foundation. In 1982, Attorney Cooper was the recipient of the Charles J. Parker Award for distinguished contributions to legal services for the poor. Among his many lasting contributions to the betterment of our legal community were his efforts towards the establishment of what is now the New Haven Legal Assistance Association. Attorney Cooper left a generous bequest to the Foundation that made the Fellows Program possible.

What is the James W. Cooper Fellows Program?

In 1994, the Connecticut Bar Foundation established the James W. Cooper Fellows Program as a formal means to recognize and honor attorneys who have shown a commitment to excellence through charitable, community, professional, and public service activities. The Foundation recognizes Fellows at an annual reception in their honor and publicizes their selection.

The Fellows sponsor programs that explore topics of timely importance to the legal community, enhance public understanding of the judicial system, and address matters concerning the administration of justice in Connecticut. The long-term objective is to develop the highest ideals of the legal profession.
